# BTI Inc. - General Terms and Condition

Unless otherwise accepted in writing by BTI all purchases are subject to the following terms and conditions:

## Prices, Taxes & Freight

1. Prices are net and exclusive of all sales taxes (PST, GST or HST).
2. Applicable taxes are added at the legislated rates in place at the time of shipment.
3. Product is shipped collect, except where prepaid freight has been authorized in writing or where customer requests freight to be shipped prepaid and charge. Prepaid and charge freight is billed as a separate line item on the invoice.

## Returns

1. Regular stock items may be returned for credit within 30 days of date of purchase.
2. Product and packaging must be in new condition.
3. Returned goods are subject to a minimum 15% restocking charge unless otherwise stated on the quotation.
4. Special order products are not returnable unless specifically noted and are subject to minimum restocking charges of 25% (unless otherwise stated on the quotation) plus freight costs to return to the manufacturer.
5. Product shipped in error may be returned for full credit including all freight costs and replacement product will be shipped at BTI expense. BTI must receive notice of errors within 10 working days from the date of shipment.

## Warranty

1. All defective products will be warranted to the full extent of the manufacturer written warranty.
2. Handling and freight costs are subject to the manufacturer written policy and where allowable defective product may be returned to BTI collect.

## Terms of Payment

1. Terms of payment are Net 30 days unless stated otherwise in writing.
2. Past due amounts are subject to interest charges of 2% per month (24% per annum) on any outstanding invoice.
3. BTI retains the right to withhold deliveries of any or all goods ordered if payment is not made promptly in accordance with the terms of payment, and BTI reserves the right to alter the terms of payment specified if in its opinion the financial condition of the customer does not justify them.

## Force Majeure

BTI shall not be responsible for any loss or damage due to delay in delivery caused by fires, floods accidents, riots, acts of God, war invasions, sabotage, governmental interference, strikes, labour difficulties, shortages of labour, fuel power materials or supplies or any other case or causes beyond our reasonable control.
